Triggering Events/Assessments for Hospice Referrals

When is the 'right' time to suggest hospice service to a home care client? What does a home care clinician need to know about hospice in order to respond to client or family questions, and discuss with the physician or hospice agency? Hospice patients often reflect on their late referrals or admission to hospice with regret, yet despite this disclosure, the national average of enrollment is only 51 days with 35% dying within seven days. Learn ways to start the discussions that are sensitive, timely and knowledgeable.

Discussions of the benefits and burdens of interventions/treatments readily available for most individuals requires training, comfort level and the ability to share information in a timely, honest and forth-right way. The home care clinician may have the most frequent health care professional interfacing with the client. The relationship of trust is a great platform on which to start the conversations.
