**ELECTRONIC FILES or EMAIL ATTACHMENT** – These files provide you with access to the data to sort, compare and analyze in any way (i.e., visit ratio comparison of for-profit versus not-for-profit agencies in various areas of the state; visits per admission benchmarks, etc.). This is a great way to access information on market share by county or diagnosis information.
